APPLICATIONS AND GUESTS:

- 1. Sullivan County Deputy Registrar Renee Simino provided recording information on plans and other documents to the Board. RS noted all Sullivan County transfers are available beginning with 1827.
- 2. Driveway permit application, Chris and Laura Troian, Campbell Road: Due to the recent snow fall members were unable to view site. There was consensus that due to terrain (flat and straight) and lack of traffic (end of Town maintained road), sight lines are sufficient. Motion AK/FE to approve the driveway permit, passed.
- 3. Class 6 Road building permit application, Chris and Laura Troian, Campbell Road: Motion AK/FE to advise the Selectmen that PB finds no issues with this building permit application.
- 4. Clayton Platt, Greg Bascom, Preliminary Consultation Minor Subdivision and Annexation, Charlestown Road: CP provided a preliminary plan. The plan shows a new lot created by combining the farm house and barn of the old Roy Farm into one lot crossing the Charlestown Road. Sections of the new lot on either side of the road will have the same map and lot number. Property on both sides of the road have been intrinsically involved historically as comprising the farm. A public hearing will be scheduled for April.
